PREVENTATIVE MAINTENANCE & HOUSING QUALITY STANDARD INSPECTIONS

South St. and Gillespie St.-HQS Inspections will take place on January 8th and 9th.

Please make sure your unit is up to the Housekeeping Policy standards at all times.

*Q&A (Quality Assurance) inspections may take place on work orders and inspections anywhere from 3-5 days after the inspection/work order happened.

Repayment agreements will no longer be extended past 90 days. This means you will have 3 months to pay off any charges if you choose to enter into a repayment agreement with MCHA. Any existing repayment agreements will not be altered or changed, but moving forward for any new agreements you make, you will only have 90 days to pay amount in full. With all payment agreements, if you miss a payment you will have to pay the amount owed in full or face legal action, we will no longer start a new payment agreement.
